WADSO-VE Comments

The following starts a series of comments based on the **REQUIRED ITEMS** on the
LEFT side of the ANSC 7012
VSC form.

Registration numbers must be painted or permanently attached to each side of the forward half of the vessel. State validation decals must. when required, be affixed within six inches of the registration number. The registration number consists of two letters identifying the state of principal operation (prefix), followed by a combination of numbers, and ending with one or more letters (suffix). These numbers are issued by the state and must be in plain block characters contrasting the background, and be not less than 3 inches in height. There must be a space or hyphens that are equal to the width of a letter (other than I) to clearly separate the letter and number

groupings, read from left to right, and be the only number displayed on the forward half of the vessel. In case of inflatable craft, the number may be firmly attached to the forward half of the vessel by a method which meets all other criteria.

If numbers are discolored. fuzzy, partially removed, or otherwise not clearly identifiable, the vessel does not qualify for a decal. Exceptions to this rule are: a) vessels used by a manufacturer or dealer for testing demonstration, which may display the number on a temporary plate firmly attached to each side of the forward half of the boat, b) documented vessels which must be at least 5 tons, and its identity established by the U.S. Coast Guard (these vessels must have the name and hailing port including city and state abbreviation, marked together in

clearly legible letters not less than four inches in height, in some clearly visible part of the hull and it must also have an official number marked by any permanent method which cannot be erased, on some clearly visible interior part of the hull) c) vessels used exclusively for: d) racing, e) military vessels of the United States, and f) a vessel equipped with propulsion machinery of less than 10 HP and used as a tender for direct transportation between a documented vessel and shore. These may display the number of the numbered vessel followed by a suffix, e.g. "1", as required; Lastly, sailboats without auxiliary machinery power (although some states may require them to be numbered); and ship's lifeboats. For reference, the Federal Numbering Act of 1918 established the initial

requirements for numbering of recreational boats. Later on, The Federal Boating Act of 1958 transferred jurisdiction from the federal to state level. In 1971, the Federal Boating Safety Act was enacted to cover all general requirements for recreational vessels. The owner/operator of a vessel must carry a certificate of number when the vessel is in use. When moved to a new state of principal use, the certificate is valid for 60 days. When a vessel changes owners, is it necessary for the new owner to apply for a new registration number or certificate of number?

- a. No, unless the new owner is leaving the state, since the number stays the same.
- b. Yes, even if the new owner is staying in the state and the number stays the same.
- c. This is one of those items requiring VE knowledge of the local/state laws since individual states have different requirements.
- d. Yes, but if the new owner trades in one boat for the other, the owner can just transfer the numbers from the old boat to the new boat without incurring the cost of a new registration.

- a. They need to have a VSC first.
