



The 2013 goal for D11NR is 12,500 VSC's. We are 5% of our goal and 47% of 2012 production. Stats from AUXINFO* indicate that 78% or 535 have passed, 196 or 28% are First Time VSC's, and 321 or 47% are High Risk VSC's. In addition, 65 VSC's or 9% are paddlecraft VSC's. The data source is AUXINFO*.

W-VSC Questions: Back by popular demand! These are actual test questions from the 2007 VE Exam Version "F" Answers can be found in another location in the newsletter 1-You are checking a 21' cuddy cabin boat with a 200 hp outboard. You are in a state that requires operator certificates for anyone born after September 30, 1970. From a conversation with the owner it is obvious that s/he is 22 years old and hasn't taken a course and does not have the certificate. If everything else is ok, can this boat be issued a VSC decal?

- a. No, under State Requirements the VE must check all Sate Requirements in addition to Federal Regulations. It is important the VE keep apprised of all state requirements.
- b. No, since you are a knowledgeable VE, you realize the danger of having an uneducated boater out on the waters and rightly withhold the decal.
- c. Yes, the VE is not law enforcement. But the VE should call the local marine authorities and get this unsafe boater off the water.
- d. Yes, since the VE is only responsible for checking equipment directly related to vessel safety or items on the VSC checklist. However, as part of the one-on-one exchange, recommend the owner take an approved course.

2-A VSC is being performed on a 16' boat equipped with a 150 hp outboard motor. The capacity plate shows a maximum horsepower rating of 90 hp. The VE should:

- a. Award the decal but advise the boater that the boat/motor combination is unsafe.
- b. Withhold the decal and advise the boater that the boat/motor combination is unsafe.
- c. Ward the decal since boat horsepower and capacity plates are not VSC requirements.
- d. Withhold the decal and report the boater to the local marine law enforcement authorities for their own good.

National News

The US Coast Guard has just issued two new safety alerts that all recreational boaters should heed.

The first alert describes the discovery of counterfeit fire extinguishers, and begins this way:

"The Coast Guard has recently become aware of counterfeits of U.S. Coast Guard approved portable fire extinguishers manufactured by Amerex Corporation and Buckeye Fire Equipment. Both companies are major producers of genuine approved fire extinguishing equipment and serve a worldwide market. These counterfeit extinguishers present a significant safety hazard. Their capability to extinguish a fire is unproven; they may be charged with a powdery substance that is not a fire extinguishing agent, the pressure cylinder is not DOT approved, and the pressure gauge may not function or give false readings..."

The second alert pertains to bow-riding in heavy weather:

"Several passengers standing in the bow pulpit of a 106' inspected whale watching vessel were injured while underway. The vessel struck a large wave, its bow rose and slammed down causing the passengers in the pulpit to lose their balance and fall to the deck. Injuries ranged from cuts and bruises to a broken patella (knee) and jaw. Although there were many other passengers on board at the time, only the passengers standing in the pulpit were injured..."
